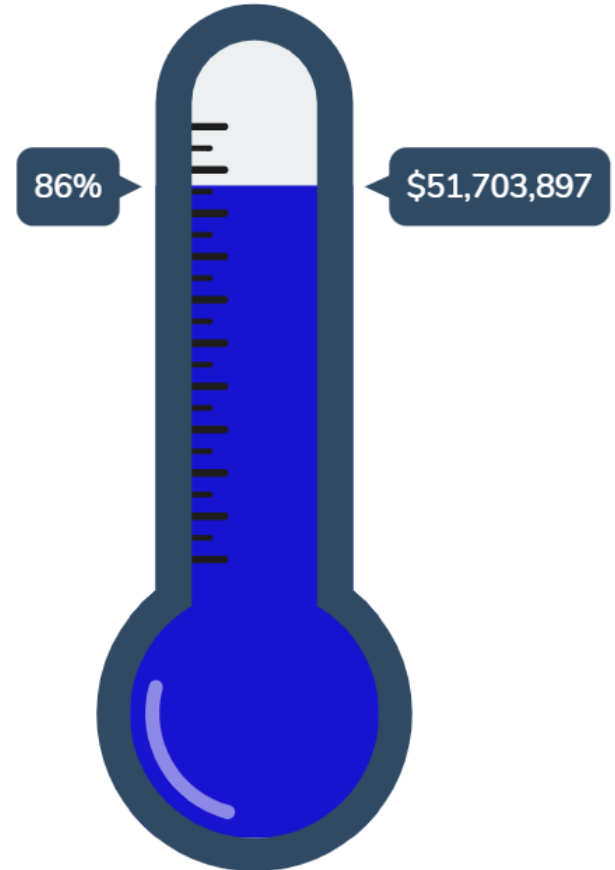
Contractor Procurement
