1. Public hearing opened at 7:00pm by PAB Chair S. Jones

Chair S. Jones informed all meeting participants that this public meeting will be recorded followed by introductions of PAB members, staff, guest, and members of the public.

2. Presentation Draft FY 2023 Consolidated Annual Performance and Evaluation Report (CAPER)

Ann Hawkins presented the 2023 CAPER for the City of Hillsboro, highlighting the program's achievements and financial allocations. Key Highlights:

- Total CDBG allocation for the year: \$695,024.
- 100% of funds allocated to community projects; no administrative funds retained by the city.
- Partner with organizations to expand affordable housing, rehabilitation of housing, improve public facilities, and affirmatively further fair housing.

Achievements included:

- Eight first-time homebuyers assisted via the Proud Ground Community Land Trust model.
- Rehabilitation of 15 homes.
- Two public facility improvement projects serving 1,913 individuals.
- Fair housing events held citywide.
- 99% of beneficiaries were low to extremely low income

A. Hawkins noted public comment continues until Tuesday, November 26th 2024.

- **C. Hartye** commended A. Hawkins for her efforts since joining the City of Hillsboro in October, noting the significant progress made in a short timeframe.
- **T. Papen** expressed gratitude for the presentation and asked about outreach accessibility for non-English speakers. **C. Hartye** clarified Proud Ground's prioritization of communities of color and non-English speakers, and noted that public facility projects, such as shelters, influenced demographic outcomes.
