# Policy Advisory Board Meeting

#### 1. Call to Order and Attendee Introductions

Board Vice Chair Kim Young called the meeting to order at 7:01 pm. Attendees introduced themselves.

# 2. <u>Community Connect Presentation, Community Action & Family Promise of Tualatin Valley</u>

Icis McQueen provided an overview of Community Connect and how it works within Washington County. Elise Laubach from Family Promise of Tualatin Valley presented on the Emergency Solutions Grant (ESG) program and how community members can access these funds through the larger Community Connect Process.

Icis McQueen with Community Action began with an overview and function of Community Connect.



## What is Community Connect?

- Community Connect is the Coordinated Entry System for Washington County.
- We serve as the main access point for individuals and families who are experiencing homelessness to get connected to housing resources and shelter
- We also manage the referrals to all of the shelters in Washington County (aside from DV) and most of the housing programs\*.
  - \*Community Connect does not manage or have involvement with Section 8, low-income housing, or sober living programs.



## **Community Connect Quick Facts**

- · We cannot provide immediate assistance or shelter referrals.
- It is our goal that everyone walks away with something (resource, feeling heard).
- We can't provide information on where someone is at on the waitlist for resources.
- We cannot guarantee that everyone will be connected to a resource nor a timeline for connection.
- Our team is small (6 people) so there may be long wait times.

Community Connect does not directly enroll clients into mainstream benefits, it is designed to provide connection to resources such as Community Action programs, the nearest ODHS office, Career Boost, and Help Me Grow.

Icis went over the Qualifying Criteria and how Clients Access Community Connect.



## Criteria To Qualify For A Phase I Assessment ( )



- Client must be literally homeless (sleeping outside, in a car, or in a shelter), involuntarily doubled (couch surfing) due to financial hardship/loss of other housing, OR will become homeless within 30 days.
- Client must physically be in Washington County OR have strong ties to the community
  - Examples of "strong ties"
    - All medical providers are in Washington County
    - Support system/family is in Washington County
    - Formerly lived in Washington County but was displaced due to being priced out, etc.
  - Wanting to live in WashCo with no other ties to the community is not considered a "strong tie"

Clients can call the phoneline @ 503-640-3263, M-F 8am-12pm, and 1-5pm. They can request a phone appointment by emailing Communityconnect@caowash.org, or walking into one of the multiservice centers in Hillsboro, Beaverton and Tigard.

Following a phase one assessment, clients are asked to do a monthly check in to keep their status current. Assessments are considered inactive after 90 days of no contact and they will no longer be considered for housing resources.

Dedicated Eviction Prevention Service funded with multiple sources:

481 individuals in 2022 and 508 individuals in 2023

The ESG Eviction Prevention Service is a federal program that serves households under the 30% income. They have enrolled 28 households with 100 individuals so far in the 23-24 program year. It takes 4-6 weeks for rehousing, and 1-2 weeks when they are staying in their current housing. Approximately 40% needed rehousing. Ongoing stabilization is a huge challenge as most of the families are unlikely to be able to pick it up to meet the needs going forward. There are many reasons some are not able to self support due to child care, health, or other challenges. Elise shared the funding available exceeds the contract length and explained how that impacts the program. There is no clear path as to how to maintain the support. They are focused on finding additional funding for the program.

Elise explained the Community connect process through the phase one assessment. That works as a pathway for the referrals and to where they may be referred to.

#### 3. APPROVAL of April 11th Policy Advisory Meeting Minutes:

# 4. HOME Investment Partnerships Program – Out-of-Cycle Funding Request

Shannon presented the request for out-of-cycle funding. The HOME Investment Partnerships Program (HOME) policies allow for out-of-cycle requests to come to the PAB for consideration when there are unallocated funds available. Our Office currently has \$1,375,223.21 in unobligated funds with an additional \$600,000 returning to our Office on July 1, 2024 from a previously awarded project that did not end up using their HOME funds.

Community Partners for Affordable Housing (CPAH) has submitted a request to our Office for \$535,000 in HOME funding a sewer line replacement project at their Metzger Park affordable housing project.

CPAH is currently the only Tier 1 Community Housing and Development Organization (CHDO) in Washington County. A nonprofit organization is certified as CHDO when it meets certain HUD requirements around board of directors' composition, financial health, development pipeline, and staff capacity. CPAH is considered a Tier 1 CHDO because more than 51% of their affordable housing units are in Washington County. CPAH has been developing affordable housing in the County since 1993 – more than 30 years.

Metzger Park is a 32-unit project near Tigard in unincorporated Washington County with 12 one-bedroom units, 12 two-bedroom units, and 8 three-bedroom units. Built in 1972, Metzger Park's sewer system dates back to the building's original construction and is in severe need of repair. Funded originally under HUD LIPRHA program, the financial structure of the property prevents CPAH from establishing appropriate reserves to plan for large capital projects to replace aging building systems and limits the ability for rent levels to cover increasing operating costs. HOME funds are critical to the preservation of Metzger Park and provide "first-in" funding to leverage for other resources. Under the current operating budget, Metzger Park is unable to support any additional debt and still cover all mandatory operating costs. The allocation of HOME funds will help CPAH acquire additional funding from other public agencies to finance the repair of the property's aging sewer system in an innovative way that will allow for the property to continue to provide a safe place to live for 32 vulnerable low-income families.

Our Office has awarded HOME funds twice previously to this project – first, an award of \$49,654.83 at the time CPAH acquired the project in 2000, and an additional \$615,000 was awarded in 2015 for a rehabilitation of the project. The rehabilitation scope at that time included replacement of many key building systems including plumbing, siding, and windows, as well as accessibility improvements. The 2015 rehabilitation project did not include sewer repairs or replacement.

Total project cost is \$3,287,729. A HOME funding commitment will help CPAH secure additional resources to fully fund the project. HOME funds will not be expended on the project until all additional funding is secured. Supporting this project allows CPAH to maintain Metzger Park as affordable housing for an additional 20 years and meets the HOME eligibility requirements.

Maureen Wolf Moved to APPROVE the HOME Investment Partnerships Program – Out-of-Cycle Funding Request of \$535,000. Marianna Valenzuela SECONDED. Motion CARRIED. (10 yes, 0 no, 0 abstention)

### 5. <u>HOME Investment Partnerships Program – Proposed Application Cycle</u> Pause

Shannon presented the proposed application cycle pause. The HOME Investment Partnerships Program (HOME) policies, procedures, application, and scoring criteria are in need of significant updates. The policies were last updated in 2015 and reflect the market conditions and affordable housing industry at that time. Significant changes in local funding availability, the funding process at the state level, as well as acquisition, development and construction cost increases have occurred since then. With the ongoing work on the 2025-2029 Consolidated Plan, this is also an opportunity to shift our local policy and application to respond to these changes.

To have sufficient time and staff capacity to develop proposed changes and bring them to Your Board for review we are proposing to pause the HOME program application cycle for FY 25/26. With the out-of-cycle request before Your Board for consideration there are three projects likely to be funded in FY 24/25. Staff have been reaching out to project sponsors to get a sense of the project pipeline in the County. Currently, the state department that funds affordable housing projects – Oregon Housing and Community Services – has been overhauling their application process.

This is in part to address a large backlog of projects that already have local funding (e.g. HOME) but need state resources (primarily Low-Income Housing Tax Credits (LIHTC)). This situation has resulted in a slowdown in the project pipeline due to uncertainty of timing of funding and funding requirements. We don't anticipate many sponsors considering a HOME application for FY 25/26

Due to our allocation size from HUD and local restrictions on the limit of funding per project, HOME funds typically account for 2-5% of a project's total development cost. The added value of HOME funds in a project is how and when the HOME funds are awarded to best position each project for success in funding cycles at the state level. The more strategically we can invest HOME dollars, the more state and other resources are invested in Washington County increasing the number of affordable housing units built and households served.

Staff are working to bring a consultant on board to help with this update of policies, procedures, application and scoring criteria. HOME is administered throughout the country; working with an experienced consultant helps us glean successful program components from various jurisdictions. Funds that are unspent in FY25/26 can be carried forward to FY26/27.

Shannon addressed some questions regarding the pause that clarified what it would look like. The pause would only be for the allocation cycle for the FY 25-26, and does not apply to any out of cycle funding requests for prior year unallocated funds.

Maureen Wolf Moved to APPROVE the HOME Investment Partnerships Program – Out-of-Cycle Funding Request of \$535,000. Pam Treece SECONDED. Motion CARRIED. (10 yes, 0 no, 0 abstention)

#### 6. Final FY 2024-25 Funding Lists

Shannon presented the final FY 2024-25 funding lists. The annual allocations for Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), and Emergency Solutions Grant (ESG) for fiscal year 2024-25 were received from HUD in early May 2024. These allocations differed from our projections with a 3.5% reduction in CDBG funds, 18% reduction in HOME funds and a similar allocation as projected for ESG. This resulted in the following changes to the CDBG funding list approved by the PAB in February 2024 and our Annual Action Plan, which was submitted to HUD on May 30, 2024.

No changes were needed to the remaining CDBG projects due to the application cycle for public infrastructure and public facilities being undersubscribed. The reduced allocation is still sufficient to fully fund the two infrastructure projects as well as our Housing Rehabilitation program.

No changes were needed to the two HOME funding awards of \$1.2 million each to REACH CDC's Elmonica Station project and Community Partners for Affordable Housing (CPAH)'s Beaverton Senior Housing on 5<sup>th</sup> program. While the allocation for FY 24/25 was cut significantly, our Office has unobligated funds from prior years sufficient to make full awards to both projects.

As the Emergency Solutions Grant (ESG) allocation was not significantly different that our projections there is just a slight change in the award amount to Community Action.

All allocation reductions also reduce the administrative funding our Office receives.
