- 4. ACTION ITEM Approval of Minutes, October 10, 2024 Meeting
 - M. Wolf Moved to approve. SECONDED by T. Papen. Motion CARRIED.

- 5. ACTION ITEM Community Development Block Grant (CDBG) Proposed Policy Manual Updates
 - S. Wilson presented proposed updates to the CDBG policy manual, which included:
 - Updates to references and hyperlinks to federal regulations.
 - Integration of the Community Development Plan previously included in the Consolidated Plan into the CDBG policies.
 - o Increasing the maximum contingency fund approval limit for the Program Manager from \$10,000 to \$25,000.
 - Requiring project sponsors to assign dedicated project managers for facilities projects.
 - Aligning the policy manual with federal audit threshold changes and consolidated plan goals.
 - **K. Young** and **M. Wolf** noted benefits of the changes and requested that future updates include a redlined document or the original version for comparison. Staff committed to sending the board the previous version of the document following the meeting.
 - **K. Young MOVED** for the board endorsed the proposed CDBG policy changes. **SECONDED by M. Valenzuela. MOTION CARRIED UNANIMOUSLY**.

- 6. ACTION ITEM Community Development Block Grant (CDBG) Proposed Application Updates
 - L. Calo reviewed changes to the CDBG and ESG applications and scoring criteria, including:
 - Revisions to equity-related questions and minor corrections.
 - Updates to reflect consolidated plan goals for 2025-2029.
 - The board reviewed and agreed with proposed changes.
 - **K. Young MOVED** to approve the updated CDBG application and scoring criteria. **SECONDED by E. Lopez. MOTION CARRIED.**

- 7. ACTION ITEM HOME ARP Allocation Plan Substantial Amendment
 - K. Valdivinos presented a substantial amendment to the HOME-ARP allocation plan, recommending a preference for families experiencing homelessness based on consultations with service agencies and

community needs. The amendment aligns existing allocations with identified subpopulation preferences.

K. Young MOTIONED endorse the home ARP allocation plan substantial amendment for preferences to better align with recipients of home ARP funds to support both homelessness assistance and supportive services. **SECONDED by J. Menez. MOTION CARRIED.**

- 8. INFORMATIONAL ITEM Consolidated Plan Update
 - E. Pauley provided an update on the consolidated plan timeline:
 - Draft plan completion is scheduled for December, with reviews by community partners in January. Public comment will open in March, with a final hearing in April.
 - A public hearing will be held on December 4, 2024, to gather additional feedback.
- 9. INFORMATIONAL ITEM MISCELLANEOUS AND ANNOUCEMENTS
 - L. Calo shared updates on the Just Compassion safe parking project in Tigard and the anticipated expansion to a second site.
 - K. Valdivinos highlighted two HOME-funded housing projects expected to close in December: El Monica (Beaverton) and Woodland Hearth (Tigard).
 - S. Wilson shared future meeting updates: A potential need for a
 December PAB meeting. A January presentation on Washington
 County's Center for Addiction and Treatment Triage was
 announced.
