First note, I have nothing against the In-and-Out Burger franchise. I frequented one of them in Arizona. They are quick and efficient but accommodate a long line of drive-thru customers.

Having lived in the area for 12 years and frequently passing by the proposed fast food restaurant area, I think it is a bad idea to locate another large and busy restaurant in the proposed location. Right now a busy Chic Filet is next door to the proposed location. I hope this proposal to locate on BHH is reconsidered.

Across the street is a bank where I use the Unitus CU ATM and Uwajimaya, a large asian grocery store. When I need to exit the Unitus Credit Union drive through and enter onto BHH the businesses share the same driveway. Turning right (east) onto BHH is not too difficult but sometimes there are up to 10 cars waiting to turn left or right onto BHH. If rleft turning cars can't merge we are all stuck waiting to turn right. If cars are turning left (west) they have to wait until two lanes or eastbound traffic pass before they can get into the center lane to merge onto BHH. At the same time the center lane may have 2 to 3 westbound cars waiting to turn into the driveway to the Unitus and Uwajimaya businesses.

I can't imagine the increased log jam that will happen if more cars are coming and going from In and Out Burger across the street and the added traffic needing to use the center lane for merging and turning. There is plenty of traffic caused by businesses already located nearby: Target, two pizza restaurants, Kentucky Fried Chicken, Kaiser Permanente, not to mention entrances and exits to the 217 hwy.

Please find another location in the Beaverton area where traffic isn't so congested already.

It is not a matter of whether there is parking or even if I like in and out. This is an issue of traffic. I can see why in and out would like the proposed Beaverton Hillsdale location - there is a lot of traffic - good for business. The reality is that this is a busy tributary and logistically no place to put the other street traffic. Every time i drive by the Kaiser in and out location there is a huge line just to get to the restaurant. When this happens at the proposed location - it will spill onto Beaverton Hillsdale and into the local neighborhoods.

Home Depot, Target, Uwajimaya, Chic Fil A, Fred Meyer, Kaiser Hospital, a New apartment complex under development, all right off 217. This does not make sense and already has heavy traffic consequences. I foresee cars cutting through local neighborhoods to cut around traffic or use Waze to get to the desired destination faster.

I think that finding a location near a large parking lot like the Kaiser Station location would make much more sense - how about a spot near Washington Square where the street traffic is designed for a situation like this? In-and-Out has a great following and appears to be a good employer. The real issue has nothing to do with them as a company or dining option - it is a very bad location and once established will have long term consequences for a very busy tributary and the surrounding community.

PLEASE do not allow this very popular destination to build on the proposed location.

Your Comments

I do not support in-n-out business to be closed to the freeway. It is already difficult to drive during rush hours and having in-n-out in the area, so close to a populated area, will make it worst for every Beaverton resident. I am deeply concern about this location and I do not support it as a Beaverton Resident.

Items that should be considered part of Drive In for application of Zoning Code

Associate Parking – Parking for those serving the drive through is part of the Drive In. In N Out is mostly a drive in therefore all associate parking should be considered part of the drive in.

All drive aisles required to access the drive through within the boundaries of the facility should be considered part of the drive in. Note that In N Out specifically showed queuing in the drive aisle and noted that they had several hundred feet of additional queuing on the site. Given that In N Out intends to use these aisles as queue space it should be considered part of the drive in and not based on an arbitrary line defined to circumvent the code.

These associate parking facilities and drive aisle from the east (main) entrance are at least partially on the OC zoned property that does not allow this type of drive in and therefore the application should not be approved.

The drive aisle could be separated from the restaurant, but this would cause substantial queuing issues and increase the likelihood of impacting Beaverton Hillsdale Highway.

Combining three of parcels rezones all or part of one of the parcels to a less restrictive zone. This should not be allowed without public review and comment.

In N Out noted several reasons that the Keizer location was an outlier and should not be used for queuing and traffic counts. This location will have all the same traits except distance from another In N Out with a population base 5-7 times larger. Although the proposed location may serve a smaller geographic area the population is substantially larger. They claim it is an outlier because it serves the Portland area. It is likely even more patrons from Portland will frequent this location meaning the traffic will likely be much higher than Keizer. The Keizer location is located at the back of a commercial development that is isolated from other businesses and is not adjacent to a major thoroughfare. Point of sale and queuing data for the Keizer location should be gathered and the traffic impact analyzed based on those values adjusted for the larger population. The Los Angeles area locations used for the study serve one quarter of the population that would be served if In N Out opened 3 locations simultaneously in the Portland area. Additionally counts should be taken for the current establishments for comparison and standardized data that is wholly inaccurate should not be used. See Table 1 of the Kittelson report. The existing Azteca and Hawaiian time have never generated the traffic levels noted in the table.

In N Out misrepresented the queuing at the Keizer location by stating it is much smaller in drive thru capacity. True, the arbitrary line has a smaller queuing line than proposed but as was submitted with my original comments they can easily queue over 50 cars. As a reminder the Keizer location can queue these 50 cars without blocking any of their parking or impacting adjacent businesses. Below are photos from 16JUN22 showing queuing well beyond the arbitrary line and an employee that appears to be taking orders (last photo). Waiting in line and ordering food is most certainly queuing and part of the Drive In. For comparison at Keizer with the official line, the three lane section of parking aisle they use, and the two lanes of entrance/exit they use at times the have over 1,000 FT of queue space. The proposed location if they use the drive aisle they have less than 900 FT. In N Out also noted that the site is “much smaller. In fact the immediately adjacent area is somewhat smaller at 1.5 acres compared to 2 acres but this fails to account for adjacent parking for the development.

In N Out continued to misrepresent that they had an addition 250 FT of queuing without impacting circulation. True it does not impact adjacent roads but it will block a portion of their parking. This clearly defines the drive aisles as queuing and part of the drive in not allowed in the OC zone. Lastly they note that they did not block right of way with their traffic. But as can be seen from the previously submitted photo they do block the exit lane that is shared with other businesses.

The TMP is a condition of the Land Use action and should be approved prior to land use approval. This is the only way the public can review and comment. Once land use is approved and a building permit is issued In N Out can not be compelled to develop a reasonable TMP as the certificate of occupancy will not likely be withheld for the TMP. This also provides time for In N Out to demonstrate to all parties that there is a reasonable solution should the traffic be as substantial as the community predicts. The TMP, and temporary measures as proposed by ODOT, should not allow limiting access to adjacent businesses. Eliminating left turn access between 103rd and 107th substantially increases the risk of illegal u-turns on Beaverton Hillsdale Highway. Traffic apps could reroute patrons on to Laurel and 103rd making access to Parker Furniture very difficult.

I am a property owner on SW 102nd Ave, a few blocks from the proposed In and Out Burger. I'm writing to express my concerns about the impact that this business will have on the neighborhood. Traffic on Beaverton-Hillsdale Highway (BHH) is already heavy throughout the day. The intersection at BHH and 107th is frequently backed up on at the light due to the Chickfila there. When traffic on BHH increases, drivers leave the highway and cut through the neighborhood streets. Streets that are not meant for that level of traffic. These streets have no sidewalks, even though they are heavily used by pedestrians.

I do not believe that heavy traffic will be a temporary problem should the In and Out open. Even time I've visited an area that has an In and Out burger, there is a long drive thru line, even in Southern California where they are plentiful. A long drive thru line at this location will extend out on to BHH, further blocking traffic. We see this happening now with Chickfila. I think an In and Out burger at this location would be a major problem for those who live, work, and pass thru this neighborhood. Please deny the business application for Washington County, Oregon Casefile L2200066:

Please do not allow the construction of the drive-thru Inn-N-Out (heart disease business) at 10565 SW Beaverton-Hillsdale Highway and on the adjacent eastern property to be approved. Please place a permanent moratorium on the construction of all-new drive-thrus of any kind in Washington County.

Drive-thrus create more gridlock, block sidewalks and bike lanes and even car and bus lanes, discourage walking and riding bikes and using wheelchairs and public transit, encourage people to throw trash out of their car windows onto the street where it ends up in creeks and wetlands and the Tualatin and Willamette Rivers. The nearby Chik-fil-A on Beaverton-Hillsdale Highway, applied for and received the highest amount of car parking spots allowed and they placed barely any landscape alongside SW Beaverton-Hillsdale Highway. The northbound SW 107th Avenue currently gets gridlocked for the grease at Chik-fil-grid which blocks SW Beaverton-Hillsdale Highway and the adjacent bus stop for TriMet bus 54. This also affects TriMet bus 61 which provides service to the largest employer in Portland, Oregon which is OHSU. Bus 61 also goes the VA Medical Center to provide medical service to American military veterans.

The site of 10565 SW Beaverton-Hillsdale Highway, which is part proposed for the Inn-n-out, is already close too many existing drive-thru food businesses. This would make it even more dangerous and deadly for people walking or using a wheelchair or bike to get to the jobs, trails, parks. There are many trails and stairs that connect to and from Beaverton-Hillsdale Highway and Farmington Road. Beaverton is taking a courageous action later this year by turning a nearby crash-prone stroad, SW Western Avenue, into more of a street this year in the adjacent West Five business district in order to eliminate vehicle crashes but to help create more jobs and safer access to public transit. Nearby SW 5th Street, which the city of Beaverton sadly labels as the "5th Street Bypass" on the metal pole signs at its intersection with Western Ave, is a relatively safe route for people to stroll, walk, or ride a bike in order to cross the obstructive 217 freeway.

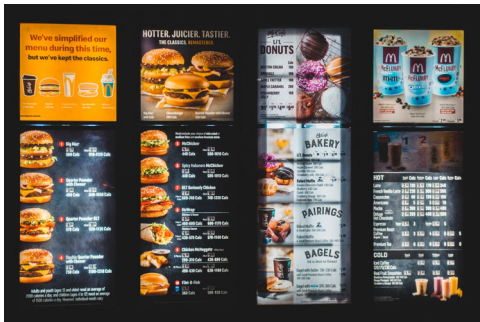
I live less than seventy feet from the West Five business district with roommates and I also work in that business district where thousands of people work. I broke a leg after being hit by a person driving a car on SW Laurelwood Avenue in Beaverton by SW Scholls Ferry Road in 2011 and I strongly advocated for the construction of a continuous sidewalk and street lamps on that dangerous street after Harley Rocher was killed in a hit-and-run crash that remains unsolved since January 15, 2013. Beaverton is finally going to build those two things this year for a street that connects several nearby schools. I have seizures and I'm grateful to have medication and I do not own or drive a car. I enjoy taking public transit, but I wish there was more north and south bus service on the westside of the Portland area and I wish downtown Beaverton had some car

parking meters. There is an extreme lack, to the east of the 217 freeway, of street lamps on SW Allen Boulevard and SW Scholls Ferry Road and SW Beaverton-Hillsdale Highway and SW Canyon Road. Please do not allow the all-new construction of any more drive-thrus of any kind anywhere in Washington County.

The heat wave of the summer of 2021 clearly showed that giant asphalt parking lots help lead to the death of people. So many lives were lost in the heat waves in the summer of 2021 in the Pacific Northwest. It is the urban and suburban heat island effect when those areas lack trees and have too many on and off-street car parking spots.

Drive-thrus are not needed in times of a virus, earthquake, or any crisis.

This memorandum is intended to supplement our oral testimony to the Hearing's Officer as well as our previously submitted reports into the land use record for the proposed In-N-Out Burger on Beaverton-Hillsdale Highway. In particular, the following topics are addressed:

- Traffic during opening conditions versus trip generation during stabilized conditions
- Trip estimates for the two restaurants currently on-site
- Traffic Management Plan performance metrics
- Potential additions to the geographic scope addressed by the TMP

Traffic during the Opening versus Stabilized Conditions

The evaluation of the four access scenarios studied in collaboration with the Oregon Department of Transportation (ODOT) and Washington County staff are based on a "stabilized" scenario:

- A "stabilized" trip generation scenario is one in which more than one store is open in the Metro area and the store is operating under what can be considered typical (i.e., not opening period) conditions.
- In-N-Out Burger stores are not open until 10:30 AM so the analysis focused on the weekday PM peak hour.
- The trip generation rates (discussed herein) are based on measured rates at other In-N-Out locations and reflective of both in-store dining and drive-through options available to customers. In-N-Out Burger stores typically operate with approximately 50 percent in-store dining and 50 percent drive-through.

In contrast, opening period traffic conditions (i.e., during the initial period in which heavier traffic is anticipated) are addressed through a Transportation Management Plan (TMP) that will be custom-tailored for this site in coordination with the City, County, TriMet (if applicable), ODOT, the Washington County sheriff's office, and any other impacted service providers.

Trip Generation

On behalf of In-N-Out Burger, Ganddini Group, Inc. (traffic engineers headquartered in California) has collected and analyzed trip generation and queuing data at several In-N-Out Burger stores to help guide the evaluation of transportation impacts during “stabilized” conditions. As discussed in our access report, the stores evaluated were agreed upon with the agency staff and include:

- Fort Worth, Texas – at the time of the data collection, this store represented a relatively new/emerging market for INO in the geographic area
- Six locations within California, including Redwood City, Rocklin, Vacaville, Fairfield, Long Beach and near the Los Angeles Airport (LAX).

Based on the seven stores surveyed, Table 1 presents the trip generation for the stabilized condition; this trip generation was included in our report and applied in our access evaluation.

In reviewing Table 1, we note that the rates are 25 – 30 percent higher than those presented in the *Trip Generation Manual* (as published by the Institute of Transportation Engineers (ITE)) for a fast-food restaurant with a drive-through window. We did not use the ITE data for our access evaluation.

Trip Generation for the Existing Restaurants

Our access evaluation presented a table comparing the trip generation that could be expected if the existing restaurants on-site were re-occupied and fully operational. However, as noted in our report, the access evaluation did not rely on those estimates but rather the actual trips measured at the driveways on the day of the traffic counts, when both restaurants had below average traffic.

Traffic Management Plan

As discussed in our reports, In-N-Out Burger opens its stores with a carefully crafted Traffic Management Plan (TMP) specific to the surrounding street network, the adjacent land uses, the number of stores in the market, and collaboration with agency staff and emergency service providers. These TMPs are prepared in detail at the time in which opening is anticipated to ensure that they reflect the conditions anticipated when the store will be opened.

As noted at the hearing, In-N-Out Burger brings in their “All-Star” team, which is a dedicated team that travels to new stores to staff operations during opening conditions and to train the locally-hired staff who will take over once it is appropriate to do so for the market. Off-site traffic management is handled by licensed traffic management firms and/or law enforcement personnel retained by In-N-Out Burger to facilitate opening period operations.

The specifics of the TMP will be developed in collaboration with the agency partners, including the applicable performance metrics. Example performance metrics can be tiered and might include, but are not limited to, the following:

- Left-turn lane providing entry access to the site exceeds available queue storage
- Entry queue at the site driveway extends to the state highway

As noted at the hearing, the metrics are not volume-to-capacity (V/C, i.e., “congestion”) based but instead are related to safety. They will also address the need to identify “dynamic performance triggers” to help In-N-Out Burger and agency partners address and respond to changing conditions during the opening period.

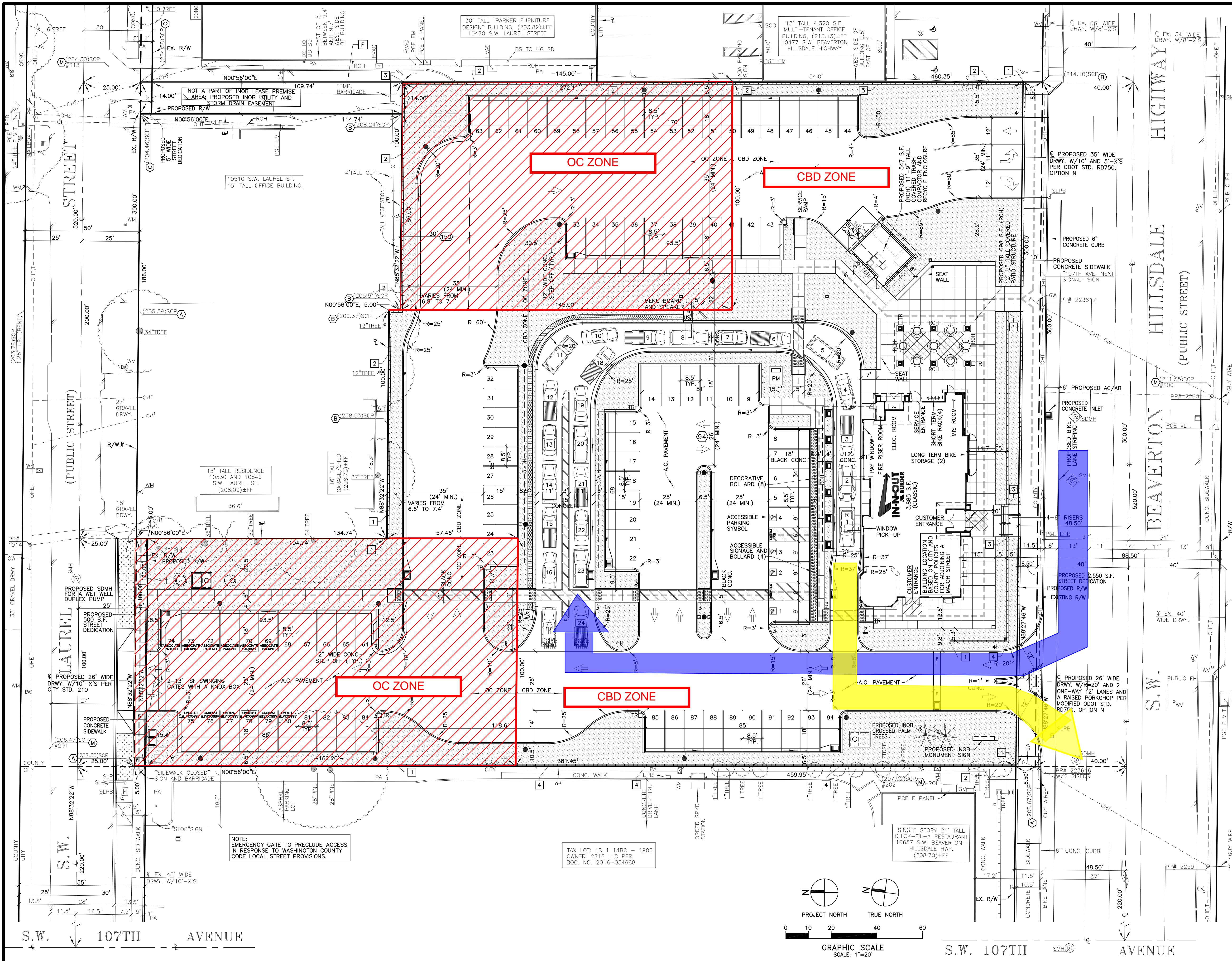
Specific transportation management actions will be identified and will include specific tactical measures to be implemented by the designated professional traffic control firm, law enforcement personnel or other parties identified in the plan.

Potential Additions to the Geographic Scope Addressed by the TMP

City of Beaverton staff and some of the residents testifying at the hearing expressed a desire to include both SW Western Avenue and the SW 102nd Avenue/SW 103rd Avenue corridor (including a segment of SW Kennedy Street connecting the two roadways) included in the TMP. Based on discussions with In-N-Out staff, the following modification to land use Condition of Approval II.8 to add II.8.f and II.8.g is proposed:

8. The TMP shall monitor and address traffic operations along the following roadways (coverage area):
 - f. SW Western Avenue between SW Beaverton-Hillsdale Highway (OR-10) and SW 5th Avenue
 - g. The SW 102nd Avenue/SW 103rd Avenue corridor (including the segment of SW Kennedy Street) between SW Beaverton-Hillsdale Highway and SW Canyon Road.

Please let us know if you need any additional information.

Traffic Management Plan Conditions of Approval

Condition II (F) 9

ODOT strongly supports the wording of the conditions of approval relating to the Traffic Management Plan (TMP) as recommended in the Staff Report. ODOT and County staff worked collaboratively to develop the condition language based on the traffic impact analysis (TIA) submitted by the Applicant. The land use decision will be based on this analysis and establish community expectations.

Queues spilling back onto the highway during the “opening period” will be managed through development and implementation of the Traffic Management Plan. The Traffic Management Plan has not been submitted for review and approval to date; nor have the traffic control measures and how they will be implemented. The definition of “opening period” and “normal period” are based on the traffic study submitted for the records (TIA). Establishing a baseline for ODOT and Washington County to determine when the TMP is no longer needed through condition II (F) 9 will provide assurance to the public that the development complies with county code criteria as it relates to safe and adequate transportation facilities. The proposed strike through removal eliminates the definition for “opening period” and “normal period” in relationship to the TIA submitted with the land use application.

Condition II (F) 11

ODOT strongly supports the wording of the condition of approval relating to the highway access during the “opening period” as recommended in the Staff Report. The proposed site plan for the development shows the eastern highway access operating with full movements into the site. Site access to Beaverton-Hillsdale Highway is regulated by ODOT through OAR 735.51. The Staff Report language establishes the measures ODOT will take to ensure that access to the highway operates safely limiting impediment of highway operations and ensuring safer access to neighboring businesses.

Hearings Officer Questions for ODOT

1. Off Site Employee Parking

It is our understanding that the applicant intends to provide off site employee parking during the “opening period” as part of the Traffic Management Plan.

2. Beaverton-Hillsdale Highway Western Access Restriction

In ODOT’s letter dated April 22nd, 2022, we stated that turning movements at the western access would be restricted to right-out only during the “opening period” and that right-in/right-out movements would be allowed during the “normal period.” ODOT has reconsidered this position and determined that right-in/right-out movements will be allowed during both periods of operation.

3. Access to Laurel St

ODOT is aware that the County Engineer has determined that access to Laurel St will not be approved. We encourage the County Engineer to reconsider the value of additional access for the proposed development to the transportation network via Laurel St. There are limited transportation facilities to accommodate the traffic demand by the proposed development. Beaverton-Hillsdale Highway is a five lane facility with high traffic volumes. Vehicle turning movements at the highway accesses will be restricted primarily during the “opening period.” Vehicles will not be able to make left turning movements out of the site. ODOT anticipates that vehicles will utilize the local streets to get to their destinations using 107th Ave, Laurel St and 103rd Ave. Vehicle access to Laurel St would benefit the safety of the ODOT transportation system and overall circulation by providing a route for left turning vehicles to use the signalized intersection at 107th Ave and Beaverton Hillsdale Highway. Access to Laurel St has been identified by ODOT as a high priority for reducing the queueing pressure on the highway and to improve safety.
