
Public Comment

Strategic Planning –

Proposed changes to bylaws:

- Proposed changes to the section 2b, officers on p5, the original by laws state that only the primary can be chair or vice chair the proposed change is that either primary or backup delegate members can hold that role.

- Chief Weiss wanted to clarify #5 if the backup delegate from an agency is chair it
 does not transfer to the primary for that agency, it is the responsibility of the vice
 chair to assume role of the missing chair role for that meeting.
- Chief Downey asked all voting members if no changes needed for someone to make a motion to approve the proposed changes to the bylaws as presented. Chief Linz made a motion to adopt, Chief Weiss seconded the motion. All voting members present are in favor the motion carries and changes are adopted effective immediately.
- Everyone has the most current version of the bylaws, minus the changes as discussed today.

- Rob McDonald would like to introduce a subject matter on how urban and suburban response zones in the county are determined, he is looking for consideration of how the zones are identified to look at the lines and make sure they are still accurate as they were 5 years ago.
- Tim brief overview urban zone follows urban growth boundary and with the last ASP update added those to the urban zone (current ASP) there was very little urban zone growth in the last 10-15 years the change that happened only included Sherwood Highschool.
- Suburban zone there was not much change there either.
- If this is something folks are willing to discuss, this is something that is discussed in the governance documents workgroups. WashCo now has a neighboring agency agreement with Clackamas County due to boundary lines cross over.
