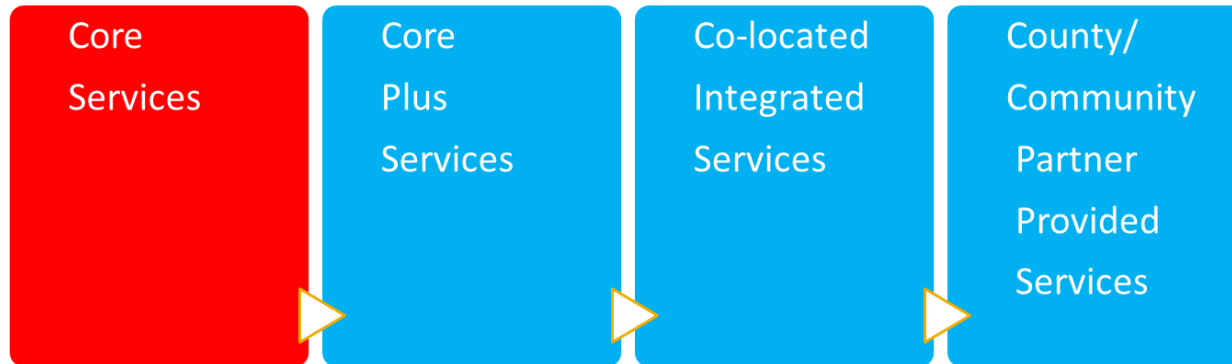

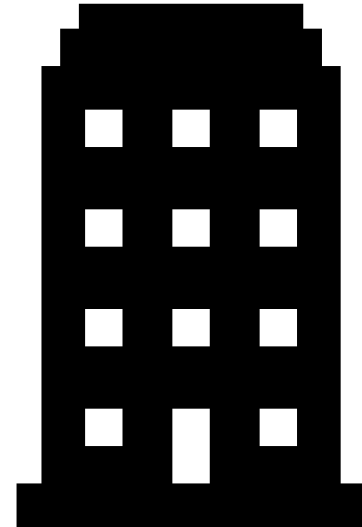


# The Big Picture: Overall Facility Design

# Services Grouping

# Core Services

Core services are critical and must be included in the program design. These services would provide much needed treatment infrastructure.

- Sobering
- Medication Assisted Treatment
- Detox/Medically Assisted Withdrawal
- Residential Services
- Crisis Stabilization

# PDWG Safety Discussion



- There needs to be two sides to the facility. This will require two intake areas and each needs to be set up differently. May even need four entrances.
- There needs to be a security entrance. Added entrances would add to the cost.
- Populations should not mingle. We need to be careful about messaging the reasons for separate areas. We need separate stairwells and doors for the safety of residents and staff.



## Safety Discussion, Cont.

- There needs to be break-out rooms for families, etc.; like what Hawthorn has in its lobby. (A room for families and a room for peers to meet with folks that are waiting.)
- We need to think through the issue of individuals with warrants sitting in the lobby and the potential presence of law enforcement in the same area. Perhaps separate entrances for law enforcement is a solution.
