Tiered Rent Program



Goals: simplified rent calculation + time for increased income

- Rents are based on a simple to read table that uses unadjusted income
- Hardship protections for large families or those with childcare expenses
- Households will only have regular reviews every three years
- Households will <u>not</u> have to report increases in income between regular reviews

Budget Process Objectives

- Continuous learning and organizational development
- Staff collaboration and decision making across the department
- Program strategies align with achieving specific key initiatives
- Informed decision making centered from an equity perspective that reflects community stakeholder needs
- Reflection and discussion on how to continuously improve the budget process

HAWC Mission

The Washington County Department of Housing Services and Housing Authority increases housing stability and creates pathways out of homelessness for the low-income residents of Washington County and their families through an integrated and coordinated system of housing and shelter strategies, including affordable housing, rental assistance, Housing Choice Vouchers, diverse shelter options and supportive services.



General Fund and Special Funds

Terms	Definitions	
Fund	A legal segregation of the County's resources and expenditures. Like a separate bank account or checkbook.	
General Fund	Primarily the money received from property taxes that are not restrictive in nature and are allocated to advance the many missions of the County.	
Special Fund	Money generated or received from a specific funding source. Its spending is restricted for a select purpose – for example Veterans Affairs Supportive Housing (VASH) funding comes from US Department of Urban Housing and Development (HUD) and is only to be used for Rental Assistance, Case Management and Clinical Services for homeless Veterans.	
Count	The Department of Housing Services currently has 3 funds, whereas the Housing Authority of Washington County has 11 funds.	



DHS and HAWC Fund Structures

Department of Homeless Services

Part of Washington County, primarily focuses on Homeless Services including Continuum of Care, Housing Navigation, Case Management, Workforce Development, Rapid Rehousing and running Shelters.

Homeless Services

- US Department of Housing and Urban Development (HUD) funding with grant matching from County General Fund, County Public Safety Levy and Supportive Housing Services Levy for Continuum of Care efforts.
- Some of these efforts include Shelter Plus Care, Legislative Bills, Executive Orders and other Homeless Programs.
- The financial activities are recorded under Fund 218.

Metro Affordable Housing Bond

- Metro Affordable Housing Bond allotment for the acquisition, development and reconstruction of properties to convert them to Low Income Affordable Units.
- The financial activities are recorded under Fund 219.

Metro Supportive Housing Services

- Metro Supportive Housing Services Levy funding for advancing homeless services.
- Some of the programs include Shelter, Outreach, Rapid Rehousing, Housing Case Management, Recuperative Care and other wrap-around services.
- The financial activities are recorded under Fund 221.

Housing Authority of Washington County

Partnership with Washington County, primarily focuses on Housing like Rental Assistance, Housing Development, Affordable Housing and Public Housing.

Housing Choice Vouchers

- US Department of Housing and Urban Development (HUD) funding to provide rental assistance.
- The financial activities are recorded under Fund 402, 404 and 406.

Public Housing

- US Department of Housing and Urban Development (HUD) subsidized rent received to maintain low rent public housing.
- The financial activities are recorded under Fund 407 and 410.

Affordable Housing

- Below fair market value rent collected to maintain and offer Affordable Housing to the underserved community.
- The financial activities are recorded under Fund 412, 415, 416 and 422.

Local Fund

- Money received from developer fees, management fees and various funding sources to advance housing development activities.
- The financial activities are recorded under Fund 414.



Housing Advisory Committee Role

By involving community members in the budgeting process, the Housing Authority can ensure that community needs and priorities are reflected in the budget and that the budget aligns with the Housing Authority's overall goals and objectives

- ☐ Provide oversight and input on the budgeting process
- Review the proposed budget, identify priorities, analyze revenue and expenditure trends, and make recommendations to the Housing Authority Board for the adoption of a final budget
- □Play a role in communicating with the public about the budgeting process, addressing community concerns and ensuring transparency


Duties and Responsibilities

- Provide an opportunity for public input during one meeting
- Receive and analyze the proposed budget
- Revise the proposed budget if necessary
- Approve budget and recommend to the Housing Authority Board
- Housing Authority Board will review, revise, approve and adopt the budget
