Purpose of Today

- Washington County will receive a second allocation of ESG-CV2 funding: \$2,214,134
- Through the prior consultations two needs clearly came up that are ESG-eligible: rental assistance and shelter support
- OCD would like to identify gaps or needs that are not currently being met in our current system and could be addressed with the new \$2.2M.

Quick Recap: CARES Act

CARES Act

- Coronavirus Aid, Relief and Economic Security Act
- Signed March 27, 2020
- Five Billion for CDBG Program nationally
 - \$1,311,034 to Washington County
- One Billion ESG1 Program nationally
 - \$662,721 to Washington County
 - >\$2.9 Billion ESG2 nationally
 - >\$2,214,134 to Washington Count

Washington County, Beaverton, & Hillsboro Planning Process

- OCD with Hillsboro and Beaverton consulted with several organizations in late April
 - 36 agencies provided feedback
- Top priority needs expressed from consultations:
 - Rental assistance, assistance with past rent once the state moratorium on evictions is lifted, outreach to homeless populations, utility assistance (primarily water), food provision and transportation
 - In addition COCs also said: maintaining stable housing, resources and communications in multiple languages, resources that are accessible (i.e. not just online, culturally responsive, through culturally specific agencies, etc.)
 - Small businesses also said: technical assistance, grant/loan opportunities to stay afloat, recover, relaunch.

^{*} HUD guidance on CARES Act funding is not available yet so some requirements may change.

** Funding may also support contracted services from Oregon Law Center, Fair Housing Council of Oregon and Community Alliance of Tenants.

*** Allocations will be provided to MESO and Adelante Mujeres over the course of a two-year period as allowed by HUD as long as businesses are able to demonstrate COVID impact. Agency specific program budgets are still being developed. Unused funds may be used to support rent assistance.
