# FY2021 CoC Program Application Timeline

- 9/2/21 HUD release of Webinar and Technical Guidance
- 9/3/21 OR-506CoC release Request For Proposals (RFP)
  - 30-day notice for new and renewal project proposals
- 10/6/21 new project presentations and scoring by HSSN
- 10/8/21 CoC Board will complete rating, ranking and selection of applications
- 10/25/21 release final application for 2-week public comment period
- 11/16/21 deadline to submit application to HUD

# FY2021 CoC Program Application Funding

Funds available in the competitive grant application:

## **\$4,074,317 Annual Renewal Demand**

- 8 TH, RRH and PSH housing projects and 1 HMIS project

## **\$ 203,716 CoC Bonus**

- Bonus points for new PSH/RRH project that demonstrates coordination between housing providers and healthcare organizations
- PSH only - Acquisition/Rehab/New Construction activities must demonstrate new construction is more cost effective than rehabilitation

## **\$ 357,076 DV Bonus**

- New RRH project serving 100% victims of domestic violence

- Projects require the project sponsor agency to provide 25% match
- Project sponsors will need to review [CoC New Project Application Detailed Instructions](#) prior to proposal submittal to HSSN

# FY2021 CoC Program Eligible Activities

New project type eligible activities under 24 CFR Part 578:

- PH-PSH: Permanent Supportive Housing
- PH-RRH: Rapid Re-Housing
- Joint TH and PH-RRH: Rapid Rehousing
- SSO-CE: Coordinated Entry
- HMIS: Homeless Management Information Systems

Activities not eligible for funding:

- Street Outreach
- Day Center Operations
- Shelter Operations
- Support Services not associated with Housing or a Support Service Facility
