1. Describe your organization’s (and subrecipient(s) if applicable) experience in effectively utilizing Federal funds and performing the activities proposed in the application.

Washington County's Department of Housing Services has extensive experience effectively managing programs providing rental assistance and housing supports to homeless individuals and families. The Department is skilled and experienced in managing a range of Federal funding including CoC funds and has effectively utilized CoC funding in similar rapid re-housing projects for several years. The Department is currently the direct recipient of CoC funding for three rapid re-housing projects and works closely with subrecipient nonprofits to implement the projects. The Department also manages a locally funded Enhanced Rapid Re-housing program in partnership with several community-based partner organizations.

Just Compassion currently has multiple contracts in partnership with Washington County, encompassing staff allocations and financial assistance for two rapid re-housing case managers who serve a caseload of 40 individuals. Just Compassion also partners with Washington County as the subrecipient for a CoC-funded PSH project, Enhanced Support for Permanent Housing, that serves 10 individuals a year. Just Compassion has expanded its program and administrative capacity over the past three years to support effective implementation of these projects. Over the past year, the organization's administrative team has doubled, significantly enhancing the organization's ability to implement services and achieve desired outcomes. This growth has been facilitated by improved communication and strengthened coordination, further enabling Just Compassion to foster closer relationships with community partner organizations.

2. Describe your organization’s (and subrecipient(s) if applicable) experience in leveraging Federal, State, local and private sector funds.

The Department of Housing Services has extensive experience leveraging and aligning Federal, State, regional and local funding to build a comprehensive system of care to create pathways out of homelessness and promote housing stability. The Department's Homeless Services Division leverages HUD CoC Program funding, State funding, regional Supportive Housing Services tax revenue, and County General Fund resources to provide services to prevent and address homelessness. The Department also houses the Housing Authority of Washington County, which administers HUD and locally funded rental housing and rental assistance to more than 7,000 households across Washington County. The Department also partners and contracts with a large network of community-based providers that leverage significant private sector funds through grants and individual donors to support their programs.

Just Compassion leverages funding from government, private foundations and individual donors to support its programs. The organization has multiple contracts in partnership with Washington County, Yamhill County, Clackamas County, and the cities of Beaverton and Tigard, leveraging Federal and local funding for congregate shelters, street outreach, rapid re-housing, case management, and a Safe Parking program. The organization recently leveraged roughly \$15 million from various government agencies, private sector funding and internal funding to build a new shelter and Access Center.

The Department of Housing Services operates under the umbrella of Washington County as a local government entity. All financial processes and procedures operate under the direction of the County's Chief Financial Officer and Finance Department. Within the Department, the County employs a team of accountants, accounting assistants, financial analysts, and other business operations staff to ensure all departments and divisions are operating within accepted accounting principles and utilizing best practices as a public entity.

Just Compassion's Financial Director and finance department have a proven track record in handling fiscal and accounting requirements for contracting with Washington County as a sub-recipient. This includes services provided by a registered CPA.

The JC Rapid Re-Housing project will provide short-term rental assistance and case management to 10 individuals living in eastern Washington County who are experiencing homelessness. The project will build on Just Compassion's two years of experience working in the rapid re-housing field and three years in case management to effectively identify barriers and implement solutions to housing stability in order to move individuals toward independent living and a better quality of life.

Just Compassion uses research-based approaches centered around individual autonomy, motivational interviewing, intensive care, and comprehensive supports to achieve long-term success for participants. The organization is committed to centering equity in its approach to services through cultural responsiveness. A major component of this effort is focused on engaging a community of service providers to provide wraparound supports to each participant. Just Compassion continuously reaches out to culturally specific organizations to enhance participants' experiences in its programming. Just Compassion deeply believes that no single organization can provide a holistic service approach to all diverse populations, as no two cultures are alike. The organization has partnerships with Centro Cultural, Easterseals, Going Home, Communities of Color, Miracles Club, and Pueblo Unido PDX, to name a few.

Just Compassion has also built relationships with landlords and property management companies to accelerate the move-in process and establish effective lines of communication to resolve issues that may arise. This has led to housing retention rates of around 95% in all of Just Compassion's programming. These connections have and will continue to reduce the time that individuals or families experience homelessness and support them in maintaining housing.

At the start of the program, the majority of assistance will focus on identifying barriers and connecting individuals to the appropriate housing options and wraparound service providers. Just Compassion will conduct the housing search, provide rental assistance administered by the Department of Housing Services, and cover all one-time costs associated with housing. Once housed, the goal is to move individuals toward independent living. Just Compassion engages the community of service providers to enhance the success of this process. This can range from something as simple as connecting an individual with an ACP provider to something as complex as helping an individual recognize the benefits of addiction treatment. Whatever the case, the goal is to help individuals overcome the multitude of barriers they face and guide them toward independent living.

Additionally, Just Compassion approaches all of its services from a Person-Centered-Person-Driven (PCPD) philosophy. The PCPD approach to case management allows individuals the autonomy to make decisions along their housing and life development journey. Just Compassion uses motivational interviewing to help navigate counseling options and other wraparound services. Allowing the participant the autonomy to develop their own pathway forward, with guidance from the case management team, strengthens commitment to the process. This philosophy is highly studied, and the underlying research shows that improved autonomy, while not a cure, can be extremely beneficial to an individual's long-term outcome.

To support housing stability, services will be focused on livability and access to wraparound services. This includes costs related to transportation, furniture, appliances, food, and clothing. It could also include health-related items, such as an air conditioner to increase comfort during warmer months or cookware to promote healthy nutrition. This program will have a flex-fund category that closely aligns with Health-Related Social Needs (HRSN) funding through Medicaid. Just Compassion has created an extremely robust resource apparatus that utilizes community donations and partnerships with organizations like Save Lives Oregon to deliver essential supplies to those in need. This includes basic necessities such as toiletries along with Narcan and other medical supplies.

2. Describe the specific plan to coordinate and integrate with other mainstream health, social services, and employment programs for which program participants may be eligible.

The majority of the assistance Just Compassion provides for rapid re-housing participants is directed at fostering independent living. The goal is not only to enhance housing stability but also to guide participants toward independent living through tailored programming and comprehensive wraparound services. Just Compassion's approach begins by identifying barriers and devising a strategic roadmap that encompasses behavioral health, addiction treatment, job training, counseling, peer support groups, legal defense, financial growth, disability assistance, and medical treatment. While Just Compassion's program has been adapted to align with the organization's internal capabilities and objectives, it is inspired by and draws upon the principles of the assertive community treatment case management model. The core concept involves utilizing a multidisciplinary team to effectively address individual needs—a strategy that has proven successful across a diverse range of cases, particularly for individuals with behavioral health issues. For further reference, see the National Institutes of Health's paper, "The effectiveness of case management interventions for the homeless, vulnerably housed and persons with lived experience: A systematic review."

Additionally, a member of Just Compassion's team has developed expertise in connecting individuals with healthcare professionals. This sometimes involves being present to help alleviate individuals' fears of the healthcare system, but primarily, it is about facilitating access to organizations that provide healthcare services or navigation. This can be a critical component for those experiencing homelessness, as it improves their health, which in turn, increases their chances of successfully obtaining housing. The intersection of homelessness and healthcare is becoming even more apparent as this field is studied. Just Compassion engages in Healthcare Case Conferencing to assist in solving problems, staying informed, and providing better care.

 - Housing Fees. Grant funds can be used to pay fees associated with getting survivors into a safe unit via emergency transfer(s), including but not limited to application fees, broker fees, holding fees, trash fees, pet fees where the person believes they need their pet to be safe, etc.
 - Case Management. Grant funds can be used to pay staff time necessary to assess, coordinate, and implement emergency transfer(s).
 - Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).
 - Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.
- B. VAWA Confidentiality Requirements. Examples of eligible costs for ensuring compliance with VAWA confidentiality requirements include:
- Monitoring and evaluating compliance.
 - Developing and implementing strategies for corrective actions and remedies to ensure compliance.
 - Program evaluation of confidentiality policies, practices, and procedures.

 - Reporting to CoC Collaborative Applicant, HUD, and other interested parties on compliance with VAWA confidentiality requirements.
 - Costs for establishing methodology to protect survivor information.
 - Staff time associated with maintaining adherence to VAWA confidentiality requirements.


