Several APRs were delayed in submission due to updates to the 2024 requirements for the CSV file. The requirements were put in place before the HMIS vendor had updated the software and our CVS file download was not available.

The underutilization of the program is primarily due to significant staffing shortages and extended leaves of absence following the implementation of Oregon Paid Leave. Over the past seven months, we have had two housing navigator positions remain vacant despite ongoing recruitment efforts. This shortage has directly impacted our capacity to serve clients at the expected levels. Additionally, the processing time for applications, which takes approximately 30-45 days, has further delayed housing searches and placements. The combination of these factors has created a bottleneck, limiting our ability to fully utilize the program as intended. We are actively addressing these challenges through enhanced staffing coverage, weekly leadership meetings focused on increasing placements, and close collaboration with county staff to streamline the application process and improve engagement with referred families.

CoC Rapid Rehousing for Families with Children is a Housing First program leveraging Community Action’s experience pairing housing assistance and support services to help families move quickly into permanent housing, build skills, resources to end their homelessness permanently. The project will prioritize serving families engaged in the shelter system utilizing the prioritization criteria established by the CoC, in an effort to reduce the length of homelessness experienced.

Community Action will serve 30 families with children. Twenty-one housing units to be funded by HUD rent assistance with nine units receiving agency funded rent assistance. Families to access: Support Services; Case Management: Individualized goal plans based on family strengths and needs; Cohort Services: Group based services to enhance peer supports and social connections, increase motivation and celebrate progress and success. Topics to include parenting, communication, budgeting and personal wellness. Mainstream Resources: Ensuring that all mainstream resources are obtained including TANF, SNAP, OHP, and ERDC.

Housing Services--Housing Search and placement: Assistance obtaining housing focused on building relationships with existing landlords and affordable housing providers to identify available units and assist with overcoming screening barriers. Medium Term Rapid Rehousing Assistance: Up to 24 months of assistance. Employment Services--Accessing resources through the Aligned Partner Program, participants will engage in sequenced employment supports including Career Mapping, Career & Resource Planning, Career Link, Basic Skills Remediation, Pathway Training, Placement and Advancement. The focus for participants is on connecting to opportunities for career advancement to support long term economic and housing stability.

Child Centered Services

Head Start: Offers comprehensive early childhood development support with education, health and mental health services.

Developmental Screenings and Resource Referrals: The CoC case manager will complete developmental screenings and offer resource referrals for all children in each household.

Participation in all components of the family’s service plan is voluntary and there is no penalty for non-participation. Case Managers use motivational interviewing and trauma informed service delivery to engage and retain families in services. Community Action utilizes a client focused approach to case planning ensuring that the elements of the plan are driven primarily by the family’s interests and needs and are adjusted as those interests and needs change.

Program outreach and referral is aligned with Community Connect which receives referrals from various sources including Monika’s House for persons fleeing DV, an outreach team funded by PATH and ESG, Title X McKinney-Vento School Liaisons and the CoC Provider agencies.

Community Action is an active participant in the CoC and supports efforts to increase resources and develop system changes identified in the local homeless plan, Consolidated Plan and aligns with Here, Together: Federal Strategic Plan. Equity in services provided to marginalized populations.

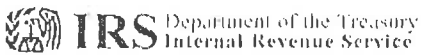
