## Ms. Emily Starbuck, Oregon Department of Employment, "Low-Income Employment and Housing Implications"

Emily Starbuck reported the comparable data reflecting, *Low Income Employment and Housing Implications*. Although there is an overall slowing in rent increases, housing prices have increased faster than wages in Washington County. Wages have increased 9% over the last five years, while fair market rents have increased 34%. Many are "rent burdened", making less than \$42,000 annually and spending 30% or more of gross income on rent.

Washington County has experienced an 8.8% population increase, primarily in the Wilsonville area; over the next five years the outer lying cities are expected to see growth. Unemployment rates in Washington County dropped to 3.7% (Oregon 4.2%); this is lower

than pre-recession rate and is a trend that is expected to continue for the next couple of years. Washington County has the highest average wage in Oregon.

In the future, Washington County can expect an increase in middle income industries, continued disparity between low wage and high wage jobs, all income categories to grow approximately 15%, and an increased need for skilled labor force.

#### V. GENERAL BUSINESS

#### FY2017 Annual Homeless Assessment Report (AHAR)

Annette Evans reviewed the draft copy of the 2017 Annual Homeless Assessment Report (AHAR). HUD subcontracts with Abt Associates and the University of Pennsylvania to compile data on use of homeless shelters and housing programs. Final data will be submitted to HUD before December 1 and posted on the County website.

The report shows a decrease in number of homeless served from 1,331 to 1,291 and increase of veterans served from 248 to 256. The decrease in persons served is a result of longer shelter stays and the housing crisis with low vacancy rate.

The race/ethnicity of persons in shelter and transitional housing is reflective of the overall diverse general population in Washington County; with the exception that permanent supportive housing is 83% white.

#### **Emergency Solution Grant (ESG) Consultation with CoC**

Matt Mattia, Office of Community Development, presented a proposed change to the ESG budget. This budget amendment will not affect services provided since agencies have other funds available for homeless prevention.

#### Update on Strategic Planning for the Next Phase of A Road Home

Four workgroups have formed and meet monthly to develop the next phase of A Road Home. During October, the workgroups have reviewed data and completed Qualitative Needs Assessments. The working draft copy of the Qualitative Needs Assessment is available on the county website.

In November, the workgroups will be reviewing best practice programs, discuss strategies that will address the gaps and needs within the homeless system. In December, the workgroups will begin developing strategies for workgroup review and recommendation for inclusion in the final plan. All planning work will be completed by end of February so the draft plan can be prepared in March and presented to the Homeless Plan Advisory Committee in April.
