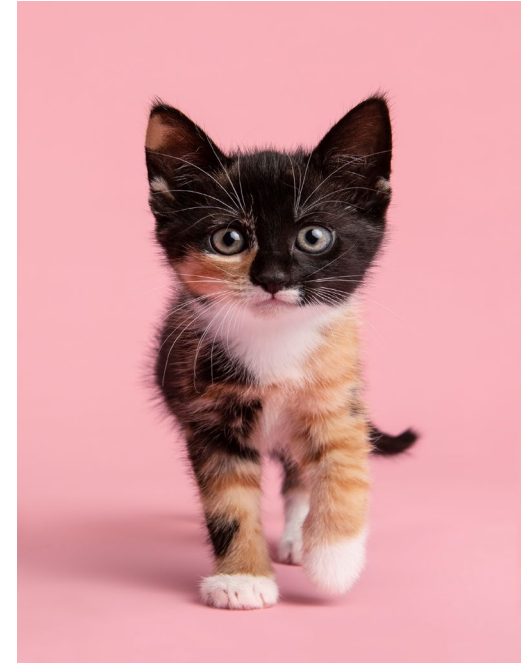

CATT Concept:

A center for treatment and support that offers rapid access to multiple types of substance use treatment. Services will include:

- Sobering
- Withdrawal management (detox)
- Residential treatment
- Transition supports
- Assessment and triage
- Co-located services





Community Need

- Lack of services locally
 - No sobering
 - No publicly funded withdrawal management
 - Few residential beds
- Impact:
 - Contributing factor for homelessness
 - People end up receiving services in emergency departments or the jail
 - Significant issue for law enforcement
- Community Feedback:
 - Project needed, lots of excitement



Who will be served?

- Adults 18 and older who have problem substance use
- People who have:
 - Medicaid/OHP
 - Uninsured individuals
 - Commercial insurance
- People will not be turned away based on coverage/ability to pay
- Services are voluntary
- Services will open in 2025

Law Enforcement Collaboration

- We have a Public Safety Workgroup that is identifying how to partner for safety for the clients, the staff, and the neighborhood.
- Members include the Sheriff's office, and leadership from the Forest Group police department, Beaverton police department, and Hillsboro police department.
- Measure 110 – Mental Health Response Team (MHRT). We are ensuring that they are aware of all the substance use disorder services and how to access them.

Measure 110 – Where It Began

- February 1, 2021 voters passed the law that decriminalized certain drugs. Receive a \$100 ticket or get help within 24 hours.
- Oregon Health Authority announcing the total grant amount of \$265,000,000 to increase services.
- The grant application came out in the fall of 2021
- We began a collaboration with our providers in August of 2021.





Services Eligible for Funding

- Initial screening for Substance Use Disorder services
- Low Barrier (access) SUD treatment
- Peer Delivered services
- ASAM screening
- Supported Housing
- Supported Employment
- Harm Reduction





Successes in Washington County

- The availability of culturally specific services has grown tremendously.
- Substance use providers are more fully connected and are working together.
- Thousands of individuals are getting help.
- New Peer Mentors have been hired.
- More housing has become available.
