

# Child Safety Seat Violations

The safety of children traveling in motor vehicles is our primary goal when enforcing the proper use of safety seats. Please follow the steps listed below to correct the violation.

1. Contact the Child Safety Seat Resource Center at <http://oregonimpact.org/Car-Seat-Resources.htm>
2. Find a listed child seat clinic that is scheduled at least one week prior to your court date.
3. Attend the child car seat clinic. Bring the same vehicle, child seat and child with you to the car seat clinic.
4. Hand the technician this form and your copy of the citation. The technician will complete the appropriate section of the form in this brochure.
5. Follow the directions inside this lier under How to Get Your Citation and Fine Dismissed.

## Understanding the Citation You Received

You have received a citation for one of the following equipment defects:

- 803.220 Failure to Change Name or Address on Vehicle Registration
- 803.300 Failure to Register Vehicle
- 803.315 Failure to Pay Registration Fee
- 803.505 Failure to Carry Registration Card
- 803.540 Failure to Display License Plate
- 803.560 Improper Display of Registration
- 806.012 Failure to Carry Proof of Insurance
- 807.010 No Drivers License (only applies to 807.062 Residency Requirement)
- 807.420 Failure to Change Name or Address on ID Card
- 807.560 Failure to Change Name or Address on Driver's License
- 811.210 Failure to Properly Use or Install Child Safety Seats
- 811.225 Failure to Maintain Safety Belts
- 811.615 Unlawful Parking in Space 1(a) and 1(c)
- 815.185 Improper Fenders or Mudguards
- 815.220 Obstructed Windows
- 815.222 Tinted Windows (less than 35% Light Transmittance)
- 815.250 Operating Without Proper Exhaust System (or Muffler)
- 815.235 No Rearview Mirror
- 816.330 Defective Lighting Equipment

## How to Get Your Citation and Fine Dismissed

The good news is that you have a second chance to comply with the law through the Vehicle Compliance Program.

Follow these steps exactly as stated before your court date:

1. Repair or correct the Violation. **For child safety seat violations, refer to the back of this brochure.**
2. Complete the Defendant's section of the form attached.
3. Bring the vehicle to the Washington County Sheriff's Office East Precinct for a vehicle inspection. **Inspections are ONLY conducted on Wednesdays (except holidays) between 9 a.m. and 12 p.m.** If the violation has been corrected, a representative of the Washington County Sheriff's Office will complete the appropriate section of the form.
4. Take the completed form, along with your citations and a \$25 administrative fee to the Justice Court.
5. The court will dismiss the citation and fine, and cancel your court appearance.

### Want to Save Time?

Immediately after your equipment inspection at the Sheriff's Office, you can deliver the required forms and the \$25 fee to the Justice Court drop box on the second floor of the same building. If you do this in advance, Justice Court will cancel your court appearance and save you an additional trip.
