Agenda Title: ADOPT FINDINGS FOR A-ENGROSSED ORDINANCE NO. 882

SUMMARY:

A-Engrossed Ordinance No. 882 proposes an exception to Statewide Land Use Planning Goals to amend the Transportation System Plan to include the Tile Flat Road Extension on rural land between Scholls Ferry Road and Roy Rogers Road. A-Engrossed Ordinance No. 882 is posted on the County's land use ordinance webpage at the following link:

Post acknowledgment comprehensive plan amendments are amendments made to the County's Comprehensive Plan after it was acknowledged by the State Department of Land Conservation and Development as complying with the Statewide Planning Goals. ORS 197.615 requires that such amendments be accompanied by findings setting forth the facts and analysis. The findings demonstrate the applicable requirements for an exception to Statewide Land Use Planning Goals have been followed consistent with the requirements of the Transportation Planning Rule. The findings also show the amendments are otherwise consistent with the other Statewide Planning Goals, the Oregon Revised Statutes, State Administrative Rules and the applicable provisions of Washington County's Comprehensive Plan.

Attached is the Resolution and Order to adopt the findings for A-Engrossed Ordinance No. 882. Prior to the Aug. 2, 2022 meeting, the proposed findings will be provided to the Board and posted on the above land use ordinance webpage.
