SUMMARY:

The Department of Land Use & Transportation and Clean Water Services request the Board join with many other public works agencies across the nation in declaring May 19 through May 25, 2019, as "National Public Works Week." This year's theme is "It Starts Here."

Since 1960 the American Public Works Association has sponsored National Public Works Week. Its 28,000 members use this week to increase awareness of the contributions public works agencies and professionals make in their communities—planning, building, operating and maintaining the infrastructure of our local communities improves our citizens' health, safety, comfort and quality of life. This celebration also offers the opportunity to express appreciation to our public works employees.

The Department of Land Use & Transportation and Clean Water Services will join other local agencies to tell the story of public works to Washington County residents. A family-friendly Public Works Fair will be held at Beaverton City Park from 8 a.m. to 1:30 p.m., Saturday, May 18. Agency partners include the Oregon Department of Transportation, the City of Beaverton Public Works Department, TriMet, Tualatin Valley Water District, and others. Media releases, posters, newsletter articles and online information will also contribute to this educational process.
