Subject: Transportation Development Tax (TDT) Expenditure Request

As described in the attached memo, the City of Beaverton is requesting approval for expenditure of \$1,000,000 for the following project:

• \$1,000,000 in TDT funds for Hall Boulevard (TDT Project List #1095 – Hall Boulevard from Scholls Ferry Road to Nimbus) to widen the structure over OR 217 to add a sidewalk on the north side and bike lanes in both directions between Scholls Ferry Road and Cascade Avenue. This project is being constructed in coordination with Washington County and ODOT.

County staff confirmed that this project is eligible for TDT expenditure and the WCCC TAC recommended approval at their April 1, 2021 meeting. Beaverton initially requested funds for an additional project, the intersection of Scholls Ferry Road and Allen Boulevard, but has decided not to pursue that request at this time.

The City of Beaverton is requesting your review and recommendation for the expenditure of Transportation Development Tax (TDT)funds on the following projects:

Project Name & Number	Requested TDT Amount
Hall Boulevard (Scholls Ferry to Cascade (#1095)	\$ 1,000,000

This \$1,000,000 funding request will be used on SW Hall Boulevard between Scholls Ferry Road and Cascade Avenue to widen the structure over OR 217, to add sidewalks and bike lanes. This is the City contribution to the project that is jointly funded by Oregon Department of Transportation (ODOT), Washington County and the City of Beaverton. The total estimated project cost is \$5,800,000.

Project Name & Number	Requested TDT Amount
Scholls Ferry Road /Allen Boulevard Intersection (#2059)	\$ 1,750,000

The requested amount will be used to realign and reconfigure the travel lanes on SW Allen Boulevard at Scholls Ferry Rd. and reconstruct the traffic signal at the intersection.


