Liz Paulus, of Cedar Mill Community Library's Adult Services, and Peter Leonard, Executive Director, will give a "Library 101" presentation, and describe the services and programs at the library; the Special Events they host; how to volunteer at the Library; and introduce the CPO 1 feature area. There will be time for questions and feedback.

Cedar Mill Community Library Association is a member of Washington County Cooperative Library Services. WCCLS provides operational funding, support services, and infrastructure to all partner agencies that operate 16 library locations in Washington County. WCCLS' funding sources include a transfer from the County's General Fund and a local option levy which expires in June 2026. One of the strengths of the WCCLS system is that each community supports their local library organization in the way that works best for them. A strength of the nonprofit community libraries is that they are deeply connected with their communities for support, whether that's through volunteering, serving on the board, or donations. The Second Edition Resale store is one of the Cedar Mill Community Library's funding sources. This spring, WCCLS will be leading the cooperative in a funding and governance evaluation process. Part of this project will be to determine funding needs for the future and evaluate sustainable funding mechanisms.
