Future Park at Heckman Lane: The District has received input from hundreds of area neighbors to design the future nature-based park at NW Heckman Lane in North Bethany. Based on this input, the district finalized the park's preliminary concept plan and name. The District is joining the April CPO 7 meeting to seek input on the new concept plan, park name, and future play areas.

Westside Trail Crossing at Highway 26: A bridge to provide bike and pedestrian access across Hwy 26 between Murray Blvd. and 158th Avenue is the planning stages. District staff will provide us with an update on planning status, funding, next steps, and timeline.

Waterhouse Trail: Improvements to the trail north of Hwy 26 are coming soon, including protected street crossings with rapid flashing beacons and bike ramps.

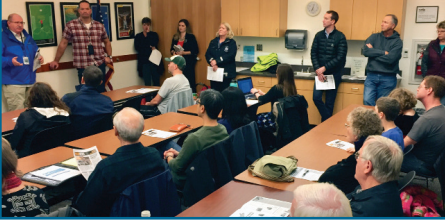
