## Oregon Agricultural Trust and the Coalition of Oregon Land Trusts

Representatives from these two organizations will share how they work hand in hand in partnership with Oregon farmers and ranchers to protect farm and ranch lands. Keeping land in agricultural production is a struggle given the average age of the Oregon farmer is 60 years old. Many acres of agricultural lands fall out of production every year as a result.



**Oregon Agricultural Trust** is an agricultural land trust that works collaboratively around the state to safeguard Oregon's farm and ranch lands and the rural communities that depend upon them. Their work permanently protects ag land, helps it stay in production, educates communities, and helps advocate for farmland preservation.



**Coalition of Oregon Land Trusts** represents more than 30 nonprofits with a mission to serve and strengthen the land trust community in Oregon. It unites conservation organizations and raises a collective voice for positive change, which includes defending working farms and ranches.
