Westside Trail – THPRD has been awarded a federal grant to complete a feasibility study and conceptual planning for a preferred trail alignment of 4 segments of the southern portion of the Westside Trail. The planning work is expected to begin in October and take 18-months to complete. Public outreach will be conducted during Winter 2025.

Raleigh Park Stream Restoration: Contractors have been carving a more natural and climate-resilient stream channel at Raleigh Park. The site will be planted with trees and shrubs this winter.

Tualatin Valley Water District

Justin Dyke shared some updates about TVWD which provides water to the southern half of CPO 3.

Current/future projects:

- -Installation of a large diameter water transmission pipeline that cuts through CPO 3 and 4 is wrapping up soon
- -This fall, the final piece of piping is going in near Western Avenue on a project that started in August of 2021 as well as some ground wrap up activities for us that's usually access vaults, manhole lids, exterior control things that are all on the side of the road and out of the way, but you'll see traffic control things and crews and trucks in the area.

 -On Allen Boulevard, it has been determined that the road restoration didn't hold up as
- expected. Joint efforts between the City of Beaverton, ODOT & Washington County have been made to tackle the work before winter sets in. everybody in the area to tackle

this work before winter sets in. Schedule and details to be announced on that project or that component of the project in the coming weeks. The main issue is with the subsurface of the road, soil conditions, and some of the areas of the pavement where we were trying to shore up new pavement and old that did not hold up as well as we were expecting.

-There will be some other smaller, less impactful work around the area until December at various locations around Scholls Ferry and Hall, typically on the side of the road or near the edge of the road inspecting access control vaults, control system panels and stuff like that all related to the underground large diameter water transmission pipe -There is more work happening at Scholls Ferry outside of CPO3 down towards Roy Rogers Road, one of the final extensive piping that has to be installed in this area. Some of this will be night work because they have to close traffic control at certain intersections. Expect this activity to go on through the end of December.


Megan Rasmussen (community outreach specialist) gave a few reminders:

- -Reminder to keep the 9 pm routine (can start sooner than 9 pm whenever it starts to get dark!) Reminder to make sure things are locked up. You bring in any valuables, turn on lights, make sure that you are.
- -October newsletter was just released and on the homepage
- -October is Domestic Violence Awareness Month. If you or someone you know are affected by it through any sort of domestic violence. There are resources available and there are many links in that newsletter for you.

Sergeant Rookhuyzen added that there is a great domestic violence resource in Washington County without having to go to the courthouse in Hillsboro. There is a one-stop family justice center in Beaverton near the Costco at 158th and Jenkins Road and Beaverton for survivors of domestic violence, anyone who's looking for counseling wanting to talk to law enforcement. You can apply for protective orders there. It's meant to make it a little easier to access than having to go to a courthouse to get family law kind of services. So it's staffed the volunteers and advocates, police officers, detectives, DHS, all the entities all in one place.

Sgt Rookhuyzen also shared about crime trends. Here is the document through the end of September. Things are steady. It's more about livability, quality of life issues that people are calling in and reporting about suspicious circumstances, welfare checks on their neighbors, and general questions. Also busy with traffic stops. They have been very busy with calls. They have had almost the same number of public-initiated calls by

the end of September this year as they had all of last year in the CPO. Busiest time of day is between 1-6 pm.

Washington County CPO 3 Follow-up/ Neighborhood Updates

Neighbors for Wetland Preservation:

Portland Golf Club has submitted applications to various agencies requesting to dredge their main pond and dump the tailings on to the designated wetlands immediately next to the Fanno Creek Nature Trail, and within 100 yards of Fanno Creek. The most recent update is that Portland Golf Club began clearing some hillside adjacent to the Fanno Creek trail at the end of 82nd Ave without a permit from Clean Water Services. That action has been halted for now, and they've now begun to apply for the proper permits.
