### **Public Safety Update**

**Sheriff's Office** Lucy Bailey updating

- New version of calls for service data (heatmap, top 10 public/deputy-initiated calls)

**TVFR** – several crew representing today, Capt Travis Kanoff reporting.

- Safety Matters materials distributed (only to library participants)
- Emergency cards distributed – fill out & leave on or near fridge
- 82% of calls EMS related – increase
- WCCCA hiring dispatchers – some can be outsourced but not ideal
- New engine has near 14k miles on it, capt pushing to get another
- 1.9 million acres burned in Oregon this year
- Reminder to check your detectors when the clocks change
- Community questions about drug overdose and ambulance protocols / adult foster care practices

### **Tualatin Valley Water District –**

Frank Reed updating

- 109<sup>th</sup> pump station – lot of pipe in the ground, appreciate community's patience
- Time to prepare pipes in house for winter freezing (turning off outside water like hoses), also prepare house for winter with crawl-space closures to keep pipes under house from freezing

- Problem – expansion of UGB westward of 175<sup>th</sup> & Scholls Fy but roadways & transit plans lag behind – how do we handle new residents while not creating climate change problems
- Gauge interest on Beaverton/Cooper Mtn Community plan & WashCo Transportation Plans.
- Concern that the people who make the plans aren't the people who need/use the roads
- Steering committee survey addresses some of this
- WashCo Policy 882 – “Around the Mountain”
- 2023 Metro study – where people live vs where they work
- Tigard & Metro independently making plans for road placement, no coordination
- Environmental interest in preserving wildlife corridors
