• Update on SW 185th Avenue Light Rail Overcrossing Project

On Sept. 17, the Washington County Board of Commissioners authorized \$750,000 of Major Streets Transportation Improvement Program (MSTIP) Large Project Matching Funds to two City of Hillsboro Grant Applications for project development and design of the SW 185th Avenue light rail overcrossing project. If the grant is not received, funds will be returned to the MSTIP Project Matching Fund.
