Public Health 101 Series

To help members better understand the role of governmental public health, we're continuing to utilize a portion of our monthly meeting to introduce public health and the sciences essential to public health.

This month Ryan Ames, Public Health Informatics Supervisor with the Research, Analytics, Informatics, and Data Program will provide an overview of public health informatics discussing what is informatics, key components of public health informatics, role of information in public health practice, and the difference between public health informatics and information technology.
