There are two major elements to making 508-compliant documents: (1) a good document structure (automatically builds in tags) that allow screen readers to read document headings, texts, and exhibits in the right order and (2) inserting alt text for any information present visually (images, graphs, flow diagrams, and graphics).



- 10. Washington County Public Health understands that trust is essential to building strong partnerships. How can the county work on building trust with the community and partners like you?
- 11. What else could Washington County Public Health do to build strong partnerships with organizations like yours?
- 12. Is there anything else you would like to share with Washington County Public Health before we wrap up?

Next steps:

Rede will analyze and synthesize findings from all community engagement from fall 2023 and spring/summer 2024. We will share findings at a community data party that all data collection participants will be invited to in August to reflect and interpret findings together. Then we will prepare a report of all findings and recommendations to Washington County Public Health at the end of September. Washington County will make that report and an executive summary available to the public. Then they will take the learnings and recommendations from community to develop strategies, actions, and outcomes for their public health plans. Plans will be finalized in June 2025.
