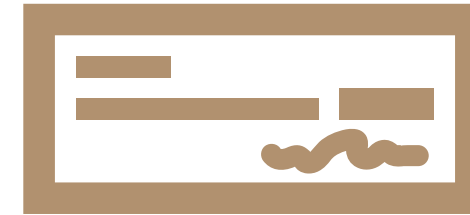


WHAT IS “ARPA”?

Investments

SURVIVING COVID-19: \$31,554,100

- Isolation and quarantine support
- Vaccination
- Testing
- Community education

MEETING BASIC NEEDS: \$3,645,700

- Basic supplies (food, diapers, etc.)
- Wraparound services for households in quarantine

Protecting public health: Washington County is Saving Lives

Our role is to protect public health *first*. We are using ARPA dollars to invest in *people*. We are already investing over *\$30M* in protecting our communities from and responding to COVID-19.

Investments

CHILDCARE: \$2,840,000

- Assessment of childcare provider capacity
- Provider grant program
- Focused childcare networks

BEHAVIORAL HEALTH: \$1,842,100

- Suicide prevention and postvention, homelessness prevention
- Behavioral health staffing

FAMILY HEALTH: \$1,070,000

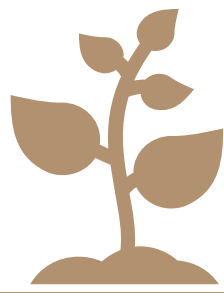
- Infant, child, and family support, community nurse staffing
- BIPOC prenatal and early childhood support

SHELTER AND SAFETY: \$1,956,600

- Services at encampments including outreach, sanitation and hygiene

UTILITY BILL ASSISTANCE: \$2,000,000

- Ratepayer assistance program - past due water/ sewer/ stormwater accounts are forgiven

SMALL BUSINESS RECOVERY: \$2,505,000

- Business Recovery Center support
- Small business support including technical assistance and access to funding

WORKFORCE DEVELOPMENT: \$2,875,000

- Job training programs
- Reskilling programs
- Wraparound services for low-income workers

BROADBAND: \$200,000

- Support a Broadband Investment Plan to understand internet access and affordability
- Other future investment planning

Community Engagement

DIVERSIFY ACCESSIBLE COMMUNICATIONS: \$235,000

- Improving county social media and creating new video streaming communications

BUILDING COMMUNITY CAPACITY THROUGH COLLABORATION: \$465,000

- Building community partner capacity in cross-jurisdictional engagement
- Leading community engagement strategies, including coaching, outreach materials, participant stipends, and related support

ADVANCING DATA EQUITY: \$300,000

- Taking a look at the tools and strategies we use to make sure our programs are making a difference and resulting in the outcomes community wants to see

Operations

Investments

OPERATIONS: \$4,420,000

Having resilient and flexible operations allows the county to continue providing essential services.

- Facilities needs including equipment, cleaning services, and PPE
- Technology support for COVID-19 public health services as well as continued teleworking needs
- Expanding communications to meet needs for timely public information access in pandemic response
- Coordination activities to plan, develop, implement, and report on COVID-19 service programs



Contingency

Investments

CONTINGENCY: \$2,697,600

- We are saving some funding because we do not know how the pandemic will continue to change. Having funding set aside allows us to respond to emergency needs that we may not have planned for.
